Update from Youth for Climate Justice (Pauline Seales)

- Online Climate Lesson (Hyperdocs formats)-Climate Problems, Data, and Solutions
- Youth Climate Justice- concerned about getting the schools to reduce greenhouse gases. Get information from power bills. Energy used for school buildings and transportation

Update from SC City (Tiffany Wise-West)

- Climate Action Plan 2020 sunsets this year. Developing a target carbon neutrality 2030-2045 over the next year or so. Reviewed the process and phases. Working with the various stakeholders on creating surveys. Our climate action plan 2030 process is starting soon and we have 2 teen interns we are working with to connect us to Harbor and Santa Cruz High. We also hope to connect to the Countywide youth climate effort. Amity Sandage is leading through these teens. There will be a lot of opportunity over the next year or so for youth participation in this climate action plan process. We are interested in involving youth in flexible ways in our plan process. Our teen interns also have individual projects, one focused on biodiversity and the other forming youth climate exchanges with our sister cities of Shingu Japan and Sestri, Italy.
- Create flexible ways to encourage youth to participate in the program.
- Launching a youth T-Shirt design contest for logos and work with the schools.
- Working with Pauline and others to increase youth participation.
- Community Workshop on November 17, 2020, to be part of the coastal planning process.

- CCRMC- Media Coalition.
 - Food Waste reduction removes methane gases and would reduce garbage waste by 40% (savings to the district)
- Transportation- District delivers the food to families. Reduces families from driving to the various school sites.

Update from Food Services – Amy Hedrick-Farr

- Amy mentioned they have been doing community feeding since March 2020.
- 2 day services on Tuesday and Friday. Deliver multiple meals on those days.
- Transitioned to biodegradable packaging.

Santa Cruz City Schools Update

- SCCS secured a second electric bus. Pending the delivery dates
- Moving away from the large vehicles and transitioning to smaller transit vans. Currently have 5 transit vans. Looking into electric trucks, but the price is around \$75k compared to \$30k.
- Facility Services Director Trevor Miller provided updates on District bond projects currently underway.
- Transitioning to greener cleaning materials

Jeremy Shonick-SCCS Trustee

- Interested in charging stations for SCCS sites. Trevor confirmed the items will cost the district, but continues to look into options.
- Carbon emissions have reduced since the pandemic, so how can SCCS continue moving this forward.

• Paper usage- suggests making a goal to reduce paper usage as a goal and present it to the board.
