- 2. MSP (Ranii/Perez-Granados) 5-0, the Board of Education upheld the denial of the Inter-District Transfer for Student #2.
- 3. At the request of the family, the hearing for Student #3 was cancelled.
- 4. MSP (Ranii/Tracy-Proulx) 5-0, the Board of Education upheld the denial of the Inter-District Transfer for Student #4.
- 5. MSP (Perez-Granados/Tracy-Proulx) 4-1, the Board of Education upheld the denial of the Inter-District Transfer for Student #5. Ms. Threet voted no.
- 6. MSP (Perez-Granados/Ranii) 3-2, the Board of Education upheld the denial of the Inter-District Transfer for Student #6. Ms. Threet and Ms. Tracy-Proulx voted no.
