## 6.1. Board Governance Study Session

Pace and Flow of Meetings & Governance Handbook

Superintendent Munro asked Trustees for input regarding the current Governance Handbook protocol about questions asked in advance of Board meetings. The Board agreed to revise the Governance Handbook to update the protocols on Agenda Questions Before a Meeting, and to include an Agreement About Missed Meetings on page 8. Trustees also discussed the use of lights and taking turns speaking during meetings. The Superintendent asked for feedback on the clarity of Bond items on the consent agenda, and presented the suggestion to use time limits for each agenda item. An agreement was made to pilot using scheduled times for agenda items this spring and review it at the next Governance session. Trustees also conferred on Closed Session protocols.

# Agreements Regarding Missing Meetings

Superintendent Munro introduced an agreement to Trustees for missed Board meetings and missed Superintendent and Trustee visits. Principal O'Meara will report to the Board in June regarding campus and community conversations regarding possible theatre arts facilities.
