#### **PUBLIC COMMUNICATIONS**

SCCCE President Chacanaca encouraged the Trustees to consider restoring some of the positions that were eliminated last school year – specifically groundskeepers and food service workers. Dr. Logsdon really enjoyed the letter from Superintendent Bloom that was printed in the Sentinel newspaper on Monday September 19<sup>th</sup>.

#### **SUPERINTENDENT'S REPORT**

Superintendent Bloom welcomed Student Representatives Holly Borg and Michelle Goodwin to the Board of Education this evening. The Superintendent reported a Harbor High School sophomore student collapsed and went into cardiac arrest while jogging in a physical education class today. Teacher Bassel Faltas administered CPR until the EMT's arrived. The student remains in critical condition after being flown to Stanford University Medical Center. Kudos to Harbor High School staff and students for the competency with which this situation was handled – and Superintendent Bloom hopes this incident serves as a reminder for folks to stay current in emergency preparedness training. Cabinet members are visiting faculty meetings at each school to touch base with the staff members and remind them that district office employees are available to support them in their important work. The Back-to-School nights were well attended at all sites with lots of positive feedback received. SCCS is promoting a "Generosity of Spirit" in our service to the community and to our team. Forms

are available at each school site and in the district office for either staff or community members to recognize an employee who has provided excellent service.

## **BOARD REPORTS and REFERRALS**

Board President Hawthorne attended the very important and successful "Food What?!" benefit fundraiser on Saturday September 17<sup>th</sup>. Ms. Hawthorne attended the Santa Cruz High School Back-to-School event. The Board President would like to share some feedback from SCCS families with Superintendent Bloom and Ms. Munro regarding the use of the internet and the "Digital Divide". Ms. Hawthorne concluded her remarks with the observation that the State continues to allow new charter schools to open when the State cannot fund the schools that currently exist.

Board Member Tracy-Proulx attended: "Food What?!" benefit fundraiser; United Way "Go For Health" Meeting; Gault Elementary School Back-to-School event. Ms. Tracy-Proulx will attend a conference this weekend regarding physical activity and wellness for children.

## **Student Representatives' Reports**

Student Goodwin is a Grade 12 student at Harbor High School. Ms. Goodwin reported that the student incident today at Harbor High School was handled extremely well by counselors, teachers, and administrators. Students are still transitioning into the new school year and finding their places in the scheme of school activities and classes.

Student Borg is a Grade 12 student at Santa Cruz High School. Ms. Borg reported a large incoming freshman class this year at the school, as well as a significant number of transfer students. The Link Crew did a great job of welcoming all newcomers to Santa Cruz High School, and the ASB officers provided great school spirit. The end result is a very welcoming atmosphere.

## ITEMS of BUSINESS to be TRANSACTED and/or DISCUSSED

## Information Item: Special Education Local Planning Area Update (SELPA)

Superintendent Bloom introduced Ms. Harriet Maglin from the SELPA to present an update on this program to the Board of Education. Ms. Maglin reviewed some of the history of SELPA and noted that currently the State of California has 120 SELPA's that are administered by their local County Office of Education. The North Santa Cruz County SELPA has 11 participating districts, and Ms. Maglin reports directly to the Superintendents. The Board thanked Ms. Maglin for her information.

## Staff Report: Response to Intervention

Ms. Munro reported to the Board of Education regarding the district Response to Intervention/Instruction (RtI). The RtI pyramid is a means by which a school organizes its instructional and school climate and intervention programs to ensure early intervention and student support. This report was informational only, and no action was taken by the Board of Education regarding this matter.

## New Business: Certify 2010-11 Unaudited Actuals and Approve Revised 2011-12 Budget

Ms. Lacey and Mr. Meza presented this report to the Trustees. Information included General Fund History, Unrestricted Reserve Analysis, Factors that Affect a Change in Fund Balance, Projected vs. Actual Funding per ADA, and the Multi-Year Projection Highlight of Revenue and Expenditure Assumptions. MSP (Dewey Thorsett/Wagman 6-0) the Board of Education certified the 2010-11 Unaudited Actuals and approved the 2011-12 Revised Budget. Students Borg and Goodwin abstained from this vote.

## New Business: Resolution 08-11-12 GANN Limit

In November 1979, the California electorate passed Proposition 4, commonly referred to as the "Gann Amendment" to the California Constitution. This is a routine resolution presented to the Board annually since the passage of Proposition 4. The worksheet recalculates the prior year (2010-11) Gann Limit based on actual ADA and revenues, and calculates the current year (2011-12) Gann Limit based on projected ADA and budgeted revenues. Ms. Dewey Thorsett moved approval, and Mr. Trujillo seconded the motion. This motion was passed by roll call vote, as follows:

Santa Cruz City Schools is one of many partners that collaborated on a grant to the National Endowment for the Arts (NEA) in order to bring a "Big Read" event to the city designed to restore reading to the center of American culture and to encourage reading for pleasure and enlightenment. During the month of October, students, staff and families from Santa Cruz Schools are encouraged to participate in "Santa Cruz Reads Edgar Allen Poe" events at many locations within the city. District Teacher Librarians are key players in the coordination of activities within the district, such as: Analysis of Poe's short stories and poems in English Classes; Critique of movies of Poe's literary works in school libraries; Writing and art contest within the schools on related themes; Possible scientific experiments relating to pendulums; visits from local authors and Poe enthusiasts to elementary sites. Santa Cruz High School librarian Veronica Zaleha presented information and was available for questions from the Board and/or the public.
