He asked the board to give latitude to make decisions and wants to move forward. - Board reports will follow the Superintendent's and Student Representatives' reports and will be limited to 2 minutes (a timer will be used).
- During public comment when you wish to speak to the speaker, use protocol for comments and questions, and wait to be called upon by President.
- Bring forward a recommendation to have the Green Schools Committee, Budget Advisory Committee, and Technology Committee made district committees. They will become non-Brown Act committees with district departments responsible for posting agendas and posting minutes. Each committee will appoint a secretary to take minutes at these meetings and staff will present annual reports to the Board of Education.

The Board appoints the following members as the "Ad hoc committee" to review resolutions suggested by Trustees, staff, or members of the public for agenda inclusion: Deborah Tracy-Proulx, Deedee Perez-Granados, and Alisun Thompson.
