SUPERINTENDENT'S REPORT

GENERAL PUBLIC BUSINESS

Resolution #17-07-08 Opposing the Governor's 2008-08 Proposed Budget

Board Member Wagman presented a revised resolution. Mr. Wagman moved approval and Ms. Strimling seconded the motion. Mr. Collins made a friendly amendment to include all Board of Education Members' signatures on this resolution. This amendment was acceptable to both Mr. Wagman and Ms. Strimling. The Santa Cruz City Schools Board of Education approved this resolution to oppose the Governor's Proposed Budget by roll call vote, as follows: (Ex. 104)

Board Study Session – 2008-09 Budget Development

Board President Hawthorne explained that the purpose of this discussion was to listen to the presentation from Mr. Moss, and take comments and questions from staff and public. Following comments and questions from the Trustees, the Board would like to ensure that Superintendent Pagano has clarified any of his questions regarding how to proceed when structuring the proposal that will come to the Board Members for approval at the Regular Meeting on February 13. Per the Boards' request on January 30, Mr. Moss presented the additional SCCS positions/FTE since the 2004-05 school year. This information included the year the position was created, the Bargaining Group, the Funding Source, and the 2008-09 Budget Projection attached to the position. Mr. Moss also presented information regarding Central Control Restricted Staffing, including the State or Federal Program attached to the position. Following discussion, the following timeline was proposed by the Superintendent: Thursday February 7 – initial discussions with site staff at the Principals' Meeting; Tuesday February 12 - Board/BFAC Meeting at the D.O., 4:00 p.m. where Mr. Pagano will introduce some initial proposals impacting Classified, Certificated, and Management; Wednesday February 13 - Trustees and Community members will have an opportunity for input at the Regular Board Meeting; Wednesday February 20 - a Special Study Session for the Board of Education with more explicit recommendations from Superintendent Pagano; Wednesday February 27 - at the Regular Meeting, the Superintendent will ask the Board of Education to take action on recommendations; Wednesday March 12 – this Regular Meeting will be the last chance to take action regarding Certificated positions prior to the required March 15 Layoff Notices.
